Written Examinations

Exam sessions are scheduled in over 20 locations across Ontario including the Keewaytinook Centre of Excellence in Dryden. Exams are scheduled by OWWCO. See www.owwco.ca for dates and locations.

Practical Examinations

For operators with over 6 years of operational experience, practical examinations may be an option for becoming a certified drinking water operator. The exams:

- Are delivered by an Aboriginal Water and Wastewater Association of Ontario assessor on-site at the operator's facility
- Allow the operator to answer questions orally or through demonstration
- Only include questions that are relevant to the facility where the operator works

A Guide to Drinking Water and Wastewater Operator Certification for First Nations



An Important and Rewarding Job

Everyone depends on clean and safe water. Water and wastewater operators serve their communities by helping to ensure the safety of drinking water and protecting the natural environment by ensuring that the wastewater is discharged in a safe manner.

Why Become a Certified Water and Wastewater Operator?

Operator certification is an important element of protecting drinking water and our natural waterways. Certification acknowledges an operator's knowledge and skills and helps to ensure that they are qualified to be responsible for supplying and treating water. Maintaining certification helps operators continually enhance their knowledge and be aware of the newest developments in the field.

Through participation in Ontario's certification program, operators can help ensure that they are conducting their duties in the safest manner possible using best management practices. The duties of an operator are varied, which makes this job very interesting.

How to Become a Certified Water and Wastewater Operator

The first step is to get an Operator-in-Training (OIT) certificate. An OIT certificate is issued for 3 years and allows a new operator to gain operational experience. The minimum requirements to apply for an OIT certificate are:

- A high school diploma (Grade 12), General Education Development (GED) or equivalent; and
- Pass the (OIT) examination.

To move to a Class I certificate, an OIT must:

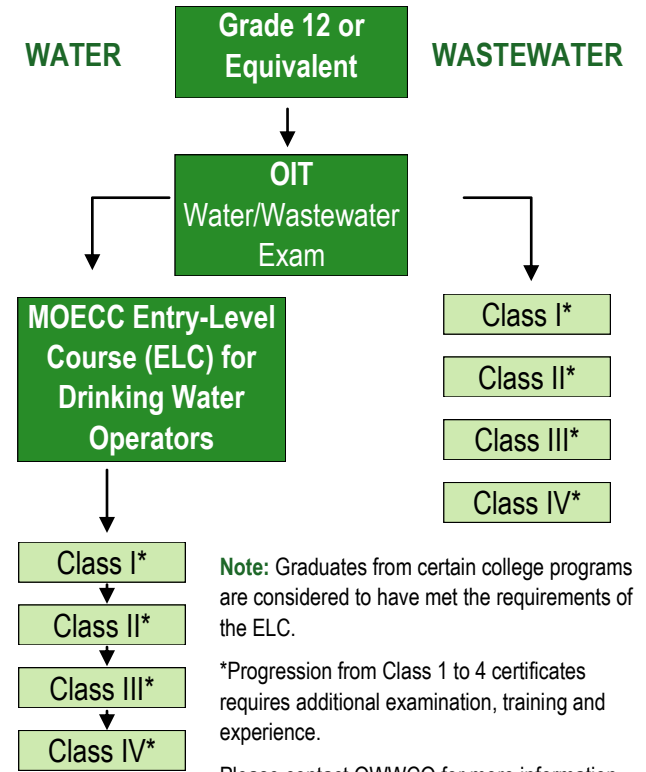
- Gain one year of hands-on operational experience
- Pass the Class I exam
- Complete the Entry-Level Course for Drinking Water Operators (for drinking water certification only)

Entry Level Course (ELC)

The ELC is a mandatory course developed by the Ministry of the Environment and Climate Change (MOECC) for all drinking water operators. The course addresses important subject matter that all operators should know. It is available to individuals interested in pursuing a career in water treatment or distribution.

The ELC is being offered at no cost. Some of the course content and delivery format were updated to ensure it meets the needs of Operators of First Nations systems. The revised course offerings started in the fall of 2017 and is being delivered throughout Ontario.

Experience

To obtain operational experience that can be used towards certification, a First Nation water/wastewater facility must have submitted an application for an assessment to determine its facility class level (i.e., I, II, III, or IV). The annual training requirements for drinking water operators are based on the highest class of system they work in. There is no cost to have a First Nation system or facility classified.
